

#### **GRAND NEST CANDIDATE NAMED**

The Edmonton Pond is executive is pleased to announce that, as a result of our recent nomination process, **PMLG Mark Robertson** has been named as our candidate for Grand Keeper of the Golden Goose Egg.



Selecting a candidate for Grand Nest is one of the first steps towards hosting the Grand Nest Convention in 2018. After the Edmonton Pond expressed its support at last June's AGM to host the 2018 Convention we expressed that intention at the Canadian Regional meeting at the convention in Calgary in July. The other Canadian ponds in attendance gave their support and approval to our bid.

Mark will be formally nominated for the position of Grand Keeper of the Golden Goose Egg at the 2013 Grand Nest Convention to be held in Quebec City from July 8<sup>th</sup> to 12<sup>th</sup>. Should he be elected then he would work his way through the Grand Nest chairs, culminating in becoming the Most Loyal Grand Gander. Edmonton Pond would host the convention in July 2018 at the end of Mark's term as MLGG.

Mark has been a very active member of Blue Goose since joining in 1984. He was MLG of the Edmonton Pond in 2006/07 and has been instrumental in the success of our charitable events. Mark's warmth and friendliness comes through whether it be on the curling ice, meeting Grant MacEwan students at a Pond dinner, or at Grand Nest Conventions. Mark has attended 3 Grand Nest Conventions including participating on the Model Initiation Team at the convention in Calgary last summer.

His Insurance career began in 1982 with Royal Insurance as a commercial lines underwriter before moving on to their marketing department in Edmonton in 1985. In 1987 Mark moved to Smithers, BC to begin a career as an Insurance Broker before returning to Edmonton

in 1990 as the manager of the Continental Insurance office. Returning to the broker side of the business in

#### **LAST FLIGHTS**

On November 1<sup>st</sup>, 2012 our friend and colleague **Brian Chatwin** took his last flight. A well respected lawyer, Brian was a 28-year member of Blue Goose. Our thanks to Vaughan Cox for providing the following remembrances of his friend and partner:



"Until five days before Brian died from cancer on November 1st he was expected to return to work at Chatwin LLP, the law firm he founded in 1979 with Nina Foster. The one battle he couldn't win lasted four months. His untimely death at age

61 was a great loss especially to his family and also the insurance and legal professions.

Known by most to be short and to the point, unassuming, intelligent, skilled in his craft, honest and a hard worker, and also known by many to be generous and kind and someone who always remembered your family history, your problems and the car you drove...Brian was in many ways "one of a kind" and a real character. Emails from his fellow lawyers described him as a "straight shooter...the epitome of integrity (you could take his word to the bank)...a big man with a big personality...[and] a rarity in our industry that became folklore long before his death". Insurance clientele noted sadly that he would be "missed immensely".

To his family, firm, friends and clients and even those in the legal profession on the other side of a file, he'll indeed be missed. In particular, Brian leaves to mourn his loss his devoted wife Sandy, three loving children Jody, Adam and Jake and a grandson Reid along with Brian's mother Eliza-

beth, sister Bonnie and his brother Robert. He was predeceased by his father Vic in 2006.

A Celebration of Life was held at the Old Timer's Cabin on November 8<sup>th</sup> with about 250 people sharing some humorous and heartfelt stories about Brian along with some Lemon Hart Rum. Farewell to a good partner in the practice of law, an even better friend, and someone I had the privilege of working with for over 28 years."

## DID YOU KNOW... 👕



Q. What's the difference between a Pond and a Pud-

A. The short answer would be size. According to the Constitution of the Honorable Order of the Blue Goose, International, in order to be granted a Charter a prospective Pond must demonstrate that the prospective membership numbers at least 50.

A Puddle may be formed under the sponsorship of an existing Pond. According to the Blue Goose Constitution, ''Puddles' may be formed by Ganders residing in a city remote from the Pond headquarters. These Ganders may band themselves together into an organization for the promotion of good fellowship, acts of benevolence among its members and furthering the interests of the Pond to which its members belong.

The Puddle officers are the Loyal Gander, Puddle Supervisor, Puddle Wielder, and Puddle Guardian. Alternatively, a Puddle may elect to adopt alternative names for the Puddle officers, specifically "Big Toad" (instead of Loyal Gander), "Polliwog" (instead of Puddle Supervisor), "Croaker" (instead of Puddle Wielder), and "Bouncer" (instead of Puddle Guardian).

In Alberta, the Lethbridge Puddle was formed under the sponsorship of the Alberta Pond. Perhaps the most distant puddle formed was the Australian Puddle which is under the sponsorship of the Hartford Pond.
